Index description

The SLI Swiss Leader Index includes the 30 most liquid stocks traded in the Swiss equity market, the developments of which are reflected by the SPI@ Family. Consequently, the index weighting of a given issue is limited by means of a 9/4,5 capping model. In other words, the weighting of each of the four companies with the largest market capitalisation is capped at a maximum of 9 %. The weightings of all lower-ranked companies are if necessary capped at 4.5 %. This limitation will be calculated by applying a capping factor, which as a general rule will remain constant for a three-month period. The SLI offers a number of advantages: for investors, the capping feature improves their stock- and sector specific diversification and, because the new index fulfils Swiss, EU and US regulatory requirements, new markets can be opened with products based on the SLI. That, in turn, generates liquidity for the stocks included in the basket.

- » Representative: the development of the market is represented by the index
- » Tradable: the index components are tradable in terms of company size and market

- » Projectable: changes in rules are with appropriate lead time (usually at least 2 trading days) no retrospective rule changes

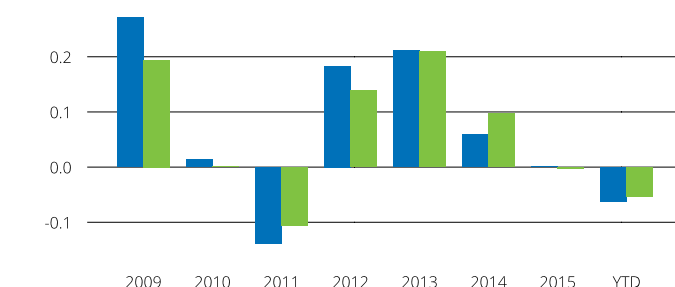

Methodology

"The weighting of the stocks within this index is based, as is the case with all SIX Swiss Exchange stock indices, on the free-float market capitalisation. To ensure that the composition of the SLI® maintains a high level of continuity, the stocks contained within it are subject to a special admission and exclusion procedure. This is based on the criteria of free-float market capitalisation and liquidity. The index-basket adjustments which arise from this procedure are, as a rule, made once per year."
