Index description

The iSTOXX Europe Climate Impact Ex GC CW & Tobacco GR Decrement 5% Index replicates the performance of the gross return version of the STOXX Europe Climate Impact Ex Global Compact Controversial Weapons & Tobacco Index assuming a constant 5% performance deduction per annum. The performance deduction accrues constantly on a daily basis.

Key facts

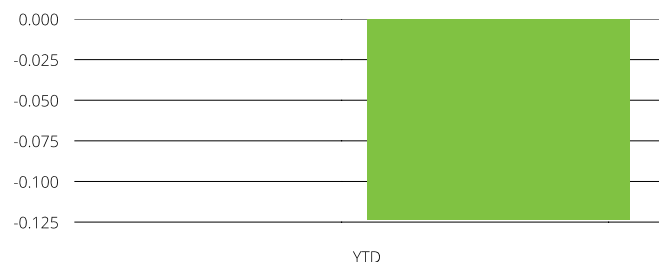
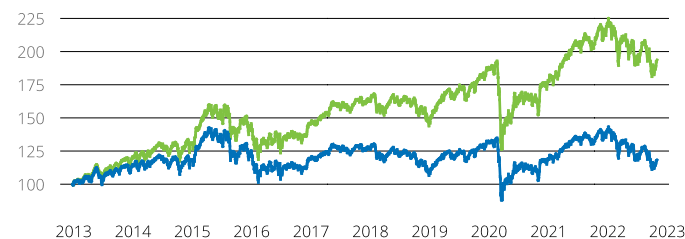
» Due to the performance deduction, the index underperforms the gross return version of the STOXX Europe Climate Impact Ex Global Compact Controversial Weapons & Tobacco Index, which includes gross dividend investments.

» The decrement index may perform better than the price version of the STOXX Europe Climate Impact Ex Global Compact Controversial Weapons & Tobacco Index, which does not consider dividend investments, if the overall gross dividend yield of the base index is greater than the value being subtracted.

Methodology

The index components and weights exactly match those of the base index: the STOXX Europe Climate Impact Ex Global Compact Controversial Weapons & Tobacco Index. It replicates the performance of the [gross/net] return version of the base index assuming a constant [5%/4.75%] performance deduction per annum. The performance deduction accrues constantly on a daily basis. All changes and adjustments to the STOXX Europe Climate Impact Ex Global Compact Controversial Weapons & Tobacco Index are reflected in the decrement index.
