Companies that are non-compliant based on the ISS-ESG Norms Based Screening assessment or are involved in Controversial Weapons are not eligible for selection. Additional exclusion filters are applied, screening companies for involvement in Tobacco, Thermal Coal, Unconventional Oil & Gas, Civilian Firearms, and Military Contracting. If less than 20% of the companies belonging to the Energy Industry in the STOXX Europe 600 are excluded by the screens, the worst companies in terms of ESG Score are excluded until the number of selected securities reaches 80% of the number of securities belonging to the Energy Industry in the underlying index.




