



Methodology

The index is derived from the STOXX® Europe Climate Awareness Ex Global Compact Controversial Weapons & Tobacco Index. Eligible companies are those that have considered the implications of climate change for, and on, their businesses, are implementing initiatives to further their use of renewable energy and are classed as ESG leaders. This is assessed using Sustainalytics transparent sustainability rating model. Eligible companies are ranked based on 12-month historical dividend yield; all stocks which do not belong to the top x% are excluded (x being calculated

as the square root of the number of eligible stocks divided by the target number of stocks, i.e. 50). All remaining stocks are ranked in descending order in terms of volatility (based on their 3- or 12-month historical volatility in EUR, whichever is higher). The top x% (50 stocks) are then selected for inclusion, provided the final composition includes no more than 8 companies from the same industry. The constituents are weighted by the inverse of their volatility with a cap at 10%. The composition is reviewed quarterly.
