For example, the STOXX Europe 600 Size Index contains 200 large, 200 mid and 200 small stocks.



Stocks in the relevant benchmark index (STOXX Europe 600) are ranked according to their free-float market cap. For the large index, the largest 200 stocks are selected, for the mid, the next ranked 200 and for the small, the last ranked 200 stocks. 
