Index description

The STOXX® Europe 600 Equal Weight Index measures the performance of the the same stocks as the standard free-float market cap weighted indices but use a different weighting scheme by attributing to each component the same weight. The index has a fixed number of components and is part of the STOXX blue-chip index family. The index captures about 60% of the freefloat market cap of the respective Total Market Index (TMI).






