STOXX publishes simulated review results of DAX 40, MDAX 50, SDAX and TecDAX SIMU Indices, under new Index Methodology entering into effect with the September 2021 Index Review

Dear Sir and Madam,

STOXX Ltd., the operator of Qontigo's index business and a global provider of innovative and tradable index concepts, announced today the composition of simulated DAX 40, MDAX 50, SDAX 70, TecDAX 30 Indices (SIMU-Indices).

The compositions are based on a simulation of the selection indices and approximate the effect of the changes to the DAX Selection Index Methodology: these changes are part of the third and last step of the implementation of the DAX Reform 2021 announced on 24th November 2020, and will be implemented during the September 2021 Index Review.

The SIMU-indices for DAX, MDAX, SDAX as well as TecDAX simulate the behavior of the indices under the new Index Methodology, namely:

- Change in number of constituents for DAX and MDAX
- Introduction of minimum liquidity requirement
- Abolition of turnover ranking in the selection process

The simulated compositions are based on the most recent ranking list with cut-off 31st May 2021 that was published on 3rd June 2021.

These simulated compositions, however, are not indicative of the future compositions of the indices that will be effective in September and only aim to illustrate the application of the rules.

As part of the transition process, in order to change the number of components in DAX and MDAX, the rules "Action in case of shortfall or surplus", as described in section 4.1.1.3 of the Guide to the DAX Equity Indices, are applied. As soon as the required number of components in the index is restored, the standard selection process applies, as described in section 4.1.1.1 of the Guide to the DAX Equity Indices.

The methodology changes for the DAX selection indices DAX, MDAX, SDAX and TecDAX will enter into effect on 30th August 2021. The index review in September 2021 will be performed according to this new methodology: the relevant ranking list, with cut-off date 31st August 2021, will be published on 3rd September 2021.
