Companies are subject to quarterly 30-15 capping, whereas the largest company is capped at 30% and the remaining companies are capped at 15%.

»Component capping ensures that no component can dominate the index.

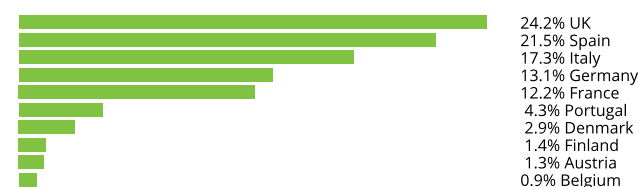

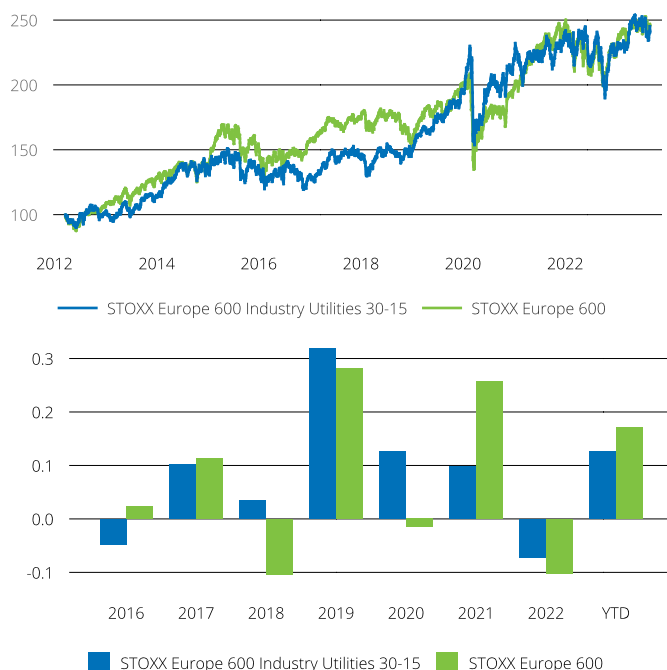
