

## Philips Electronics (NL) Announces Special Capital Repayment

Zurich, May 28, 1999: STOXX Limited, the operating company of the Dow Jones STOXX<sup>SM</sup> indexes, announces the following change in all the relevant broad, blue-chip and other Dow Jones STOXX<sup>SM</sup> indexes.

In response to the recently announced forthcoming corporate action by the Dutch technology company Philips Electronics (NL0000009256):

- Philips Electronics (NL0000009256) with 346,669,920 shares and a market capitalisation of 28.5 BEUR will make a special capital repayment of 4.1158 EUR per share, effective May 31, 1999.
- As a result of this special capital repayment, the Philips Electronics ISIN No. will change from NL0000009256 to NL0000009504, effective May 31, 1999.
- Unlike special cash dividends which are imputed in the Dow Jones STOXX<sup>SM</sup> price and total-return indexes net of the withholding tax due in the country where the stock is listed (e.g. 25% in the Netherlands)\*, the full amount of the Philips Electronics special capital repayment of 4.1158 EUR per share will be imputed in all the relevant broad, blue-chip and other Dow Jones STOXX<sup>SM</sup> indexes, effective May 31, 1999.
- \* NOTE: Special cash dividend payments are treated for the Dow Jones STOXX<sup>SM</sup> price and total-return indexes as follows:

Net special cash dividend imputed in the indexes = (Dividend announced by the company) minus (withholding taxes due in the country where the stock is listed). The withholding taxes in the countries relevant to the Dow Jones STOXX<sup>SM</sup> indexes follow:
