DAX Fixed Income Indices – New file name and format change effective November 1st, 2023

Dear Customer,

STOXX Ltd., the operator of Qontigo's index business and a global provider of innovative and tradable index concepts, provides detailed information related to the new file name and file format that will be applicable to the **DAX Fixed Income Indices files starting as of November 1st, 2023** on the New Index Data Distribution System. The **current file name and file format applicable to the Fixed Income Indices** on the Current Index Data Distribution System MD&SI will **not be maintained after February 29th, 2024**.

This announcement is pursuant to the Technical Information related to the New Index Data Distribution System and new file formats for DAX Indices published on March 27th, 2023.

As part of this technical migration, a new set of daily files for the DAX Fixed Income Indices will be created and will only be distributed on the New Index Data Distribution System.

The migration to the New Index Data Distribution System requires DAX clients to follow upcoming Technical Announcements displayed in the web section [Index Data & Resources / Index Data / Announcements / Systems & IT](#). Alerts and automatic e-mails of new communication related to this section can be already subscribed to by DAX users.

As of March 2024, the DAX File Guide will be decommissioned and will be replaced with the Index File Guide.

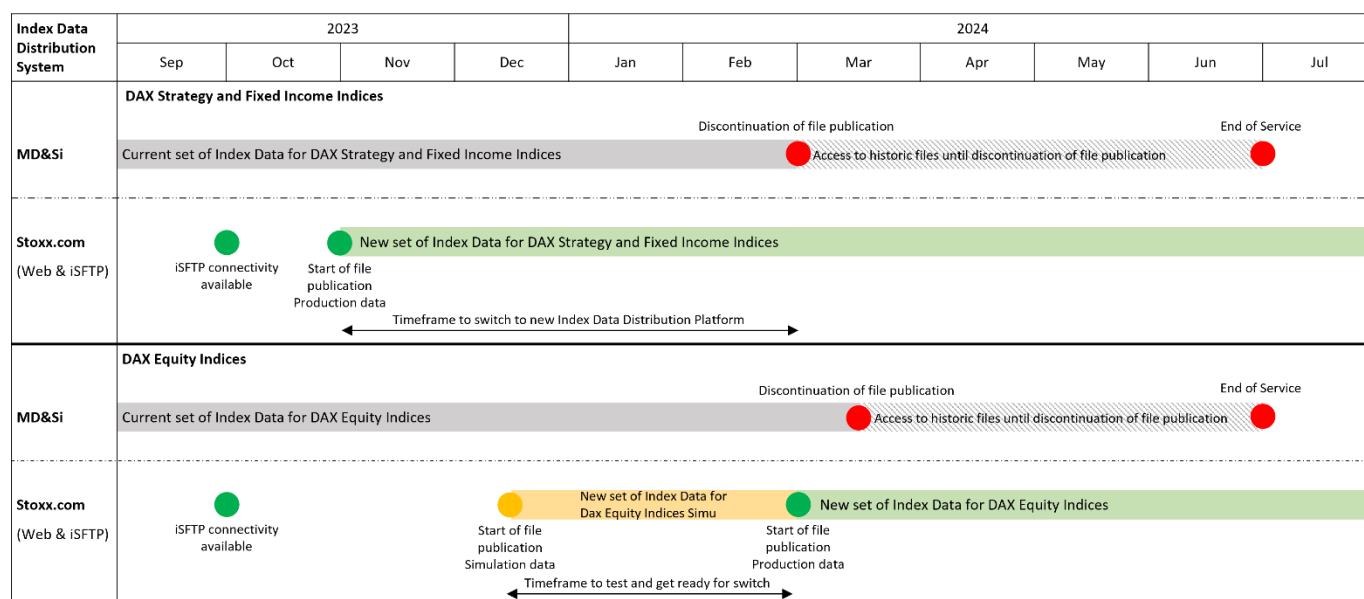

Overview of the Technical Migration – Final Timeline for DAX clients

The technical migration from the Current Index Data Distribution System to the New Index Data Distribution System aims at a smooth transition for DAX Clients from October 2023 to March 2024 and ensure full readiness step by step. The high-level timeline for the technical migration and related to the file format change for DAX Fixed Income Indices is displayed in the below graphic and is scheduled as follow:

- **October 2nd, 2023:** Clients can check entitlement and connectivity to the New Index Data Distribution System.
- **November 1st, 2023:** New file format available on the New Index Data Distribution System (Web & iSFTP) – start of parallel run.
- **March 1st, 2024:** The New Index Data Distribution System becomes the primary source for DAX Fixed Income Indices Files. The Current Index Data Distribution System MD&Si is not maintained.
