Action Required: Confirmation of Readiness for Technical Migration of DAX Indices to the New Index Data Distribution System

Dear Client,

STOXX Ltd., today announces that, as of the end of the first half of the [Simulation Phase for DAX Equity Indices](#), 74% of our clients are ready to fully transition to the New Index Data Distribution System. This follows the [Technical Migration announcement made in March 2023](#), which introduced new file names and formats for DAX Indices.

This progress has been achieved following several communications published at stox.com/systems-it as well proactive communications mainly coming from the customersupport@stox.com team to licensed entities over the last 6 months. Please be advised that the absence of feedback in response to the aforementioned communications will be interpreted as a declaration of readiness and that STOXX Ltd. cannot be held responsible for any inability on the part of clients to access or process DAX Index data following the effective date of the technical migration. We therefore advise all clients to carefully review the communications and take any necessary steps to ensure continued access to DAX Index data.
