STOXX Equity Index files - STOXX to implement new Index Reports to comply with Third-Party licensing as of April 27th, 2026.

Dear Customer,

STOXX Ltd., the operator of the ISS STOXX index business and a global provider of innovative and tradable index concepts, today announced upcoming changes to the STOXX Index files to ensure compliance with **ISIN identifiers subject to CUSIP Global Services Third-Party Data License** by **April 27th, 2026**.

As a result, STOXX Ltd., will introduce Index File names containing "P002" and "P003" in its Index Reportings framework to allow further flexibility for STOXX clients related to **ISIN identifiers subject to CUSIP Global Services Third-Party Data License**.

- **Clients with a valid CUSIP Global Services Third-Party Data License** and approved / confirmed to STOXX by CUSIP Global Services **are not affected** by the content of this Technical Information.
- **Clients with no valid CUSIP Global Services Third-Party Data License are required to take action** based on the content of this Technical Communication.
- **As of May 1st, 2026, the Index Selection Lists** applicable to DAX, STOXX, and iSTOXX indices which are **publicly available** on www.stoxx.com **will no longer include ISIN information**.

Background information related to ISIN identifiers subject to CUSIP Global Services Third-Party Data License

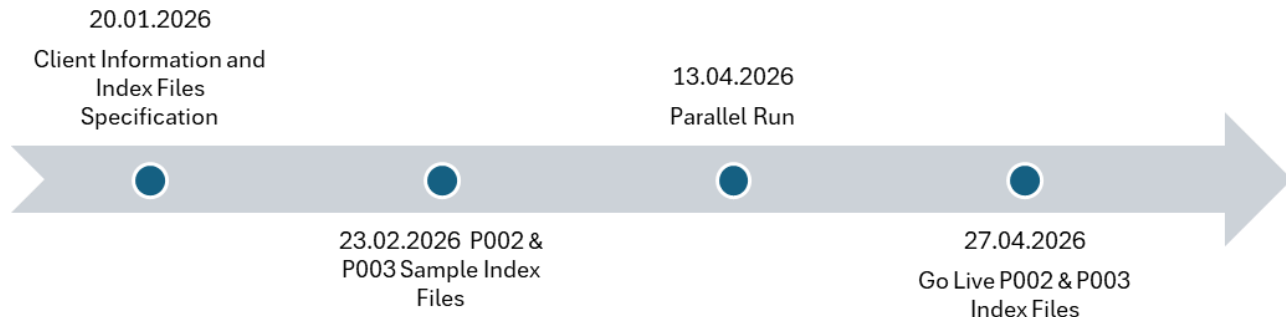
STOXX provides hereafter an extract of CUSIP Global Services public information regarding ISIN identifiers subject to CUSIP Global Services Third-Party Data License.

The International Securities Identification Number (ISIN) is a unique global code that identifies instruments to facilitate cross-border trading. There are currently over 120 recognized National Numbering Agencies (NNAs) throughout the world which are responsible for the assignment of ISINs in their respective countries. CGS is responsible for the assignment of ISINs in the U.S. and in other areas where designated or appointed. CGS has agents in countries such as Canada, Bermuda and the Cayman Islands and is also the representative agency for many countries in the Caribbean and Pacific region.

• **P002 contains securities identifiers for which there is a valid SEDOL Third-Party Data license and no valid CUSIP Third Party Data license.** Please note that the field referencing the SEDOL identifiers will contain data, while the field referencing ISIN codes will be partially filled as follow:

- ISIN codes which do not contain CUSIP code will be available
- ISIN codes which do contain CUSIP code will not be available
