# Market Consultation on proposed changes to the iSTOXX AI Global Artificial Intelligence High Dividend 30 Index

Dear Sir and Madam,

STOXX Ltd., the operator of Qontigo's index business and a global provider of innovative and tradable index concepts, has decided to conduct a market consultation on proposed changes to the methodology of the iSTOXX AI Global Artificial Intelligence High Dividend 30 Index.

The market consultation may or may not lead to changes in the index methodology.

#### **Process and Timeline**

STOXX invites relevant stakeholders and interested third parties to submit responses to consultation@qontigo.com.

The consultation is open to all market participants until September 27th, 2023.

STOXX intends to announce the results of the market consultation, as well as an announcement about potential changes to the index methodology, by October 6th, 2023.

STOXX intends to implement the potential changes resulting from this consultation with the ordinary index review in December 2023.

#### Motivation for the Market Consultation

Following the public market consultation earlier this year on the reference index methodology enhancement<sup>1</sup>, combined with client feedback, STOXX proposes to enhance the methodology of the iSTOXX AI Global Artificial Intelligence High Dividend 30 index to ensure the index alignment to its high dividend yield objective while maintaining the high AI exposure and stock liquidity.

## **Proposed Treatments/Amendments**

STOXX is looking to enhance the methodology of the iSTOXX AI Global Artificial Intelligence High Dividend 30 Index to define the FactSet RBICS sectors associated with AI and adjust the minimum liquidity.
